I, the undersigned, certify that the Special Financial Assistance (SFA) being requested by the Teamsters Local 641 Pension Plan is the amount to which the Plan is entitled under ERISA §4262(j)(1) and PBGC Reg. §4262.4.

The census data was provided to us by the Fund office, and is as of 3/1/2021. It has been reviewed for reasonableness, but we did not perform a formal audit of the data provided.

The assumptions used in the determination of the SFA are generally the same as those used in the March 1, 2019 actuarial valuation, with the exceptions listed in Template 7. Liabilities were calculated using the traditional unit credit cost method. The assumptions used are detailed below, and are unchanged from the SFA request made under the interim regulations published July 9, 2021 other than the interest rate used pursuant to ERISA §4262(e)(3).
