## **Lus Nthuav Qhia Txog Txoj Cai Ntiag Tug:**

Txoj Cai Ntiag Tug (*Privacy Act*) ntawm xyoo 1974, raws li tau hloov kho, 5 U.S.C. § 552a xav kom PBGC muab tsab ntawv ceeb toom no rau koj thaum sau cov ntaub ntawv los ntawm koj. PBGC siv cov ntaub ntawv peb sau ntawm no, uas suav nrog koj lub npe, cov ntaub ntawv tiv tauj, thiab vim li cas hu rau PBGC, txhawm rau txheeb koj hauv PBGC cov lab npauv thiab tiv tauj koj los teb rau koj qhov kev nug. Koj cov lus teb yog kev yeem. Txawm li cas los xij, kev tsis muab cov ntaub ntawv rau PBGC, suav nrog koj lub npe, cov ntaub ntawv tiv tauj, thiab lub laj thawj ntawm kev tiv tauj PBGC, tuaj yeem ncuu los sis tiv thaiv PBGC los tiv tauj koj.

PBGC tuaj yeem tso tawm cov ntaub ntawv hais txog koj rau lwm tus neeg thiab cov koom haum thaum cheem tsum thiab tsim nyog raws li 5 U.S.C. § 552a(b) ntawm Txoj Cai Ntiag Tug, suav nrog rau PBGC cov neeg cog lus hais txog cov neeg siv khoom cov lus nug; kom ua raws li Tsoom Fwv Teb Chaws cov cai lij choj uas xav kom nthuav tawm cov ntaub ntawv muaj nyob hauv peb cov ntaub ntawv teev tseg; los pab txhawb cov ntaub ntawv txheeb cais kev tshawb fawb, thiab kev tshawb xyuas los sis kev tshawb nrhiav teeb meem.

PBGC kuj tseem tuaj yeem muab cov ntaub ntawv hais txog koj mus rau Lub Chaw Lis Hauj Lwm Kev Tswj Xyuas thiab Peev Nyiaj Txiag nrog rau kev tshuaj xyuas cov cai lij choj pab tus kheej los sis rau lub chaw lis hauj lwm rau Zej Tsoom Sawv Daws hauv kev teb rau cov lus nug uas chaw lis hauj lwm ua rau koj ntawm koj qhov kev thov.
